### **Herpes Simplex Virus Advisement**

If you have ever had a **cold sore**, or **fever blister** in the past, you harbor the "**herpes simplex**" virus within your body. Everyone is different in their activity of this virus. Some may have frequent outbreaks, and some may have only had one or two outbreaks a long time ago. Nevertheless, the virus is still harbored within your body. The lip color procedure will cause an outbreak in some individuals who have this virus. Therefore, you are advised to acquire the below mentioned medication, prior to your procedure, to alleviate the possibility of an outbreak. This is an optional medication and **Spa and/or Donna Furr** does not hold any liability regarding its use or nonuse for prevention of cold sores/ fever blisters.

Please request **one** of these anti-viral medications from your Physician or Dentist:

Zovirax (Acyclovir)

Famvir

Valtrex

**Usually you will need to take the prescribed dosage of one of the medications for five (5) consecutive days. Recommendation:** Begin by taking the pills two (2) days before your lip procedure, the same day as your procedure and two (2) days following your lip procedure.

**Remember:** Each of these medications has a different dosage, so check with your Physician regarding adequate doses and administration.

Please request enough medication to cover you for all your lip color procedures.

*We all long for beautiful and full rosy lips...few people are so lucky! Redefinition of an irregular lip line can be accomplished with a lip color procedure or restoration of color that has faded.*

### **Pre-Procedural Considerations:**

- No alcohol or caffeinated products 24 hours before treatment **and** no aspirin or blood-thinning medications five (5) days prior.
- All makeup should be removed and the skin thoroughly cleansed. We prefer you do this before your arrival.
- For optimal results, the skin to be treated should not be irritated.
- If you use or have used Retin-A or any other medications, please advise the technician.
- Pain Preparation: Though the sensation of micro pigmentation implantation is minimal, clients respond differently. Some will feel a stronger sensation than others. Overall, procedures require minimal pain preparation. However, some clients use some sort of preparation for the treatment as a mental comfort. Many have taken over-the-counter Tylenol, thirty (30) minutes before treatment. This will not interfere with the procedure. Any physician prescribed pain-relieving medication for which you have arranged, should be taken as directed, usually after your arrival at the office. Please advise me of any medications taken.
- For clients with any history of cold sores/fever-blister/herpes, even if it was when you were a child, use over-the-counter L-Lysine as directed five (5) days before and after treatment or contact your physician and request a prescription for Zovirax, Valtrex or Famvir. Take as directed and repeat on all visits.
